## SECTION B

### PREAMBLE:

Courage Child Protection NPC was launched in May 2018. Courage is a powerful child protection toolkit and community engagement process that helps individuals and organisations to:

1. Recognise the rights and needs of all children.
2. Identify and empower where they are being abused or overlooked.
3. Develop the strategies they need to solve their child protection challenges.
4. Empower the individuals, organisations and community members to make a difference, in partnership with others.
5. Measure and evaluation progress to ensure sustainable change.

Now that their child protection toolkit and process has been developed, Courage Child Protection's primary role is to build relationships with and train organisations, communities and individuals in the identification and management of child protection challenges. Courage has also provided consulting support to a range of NPOs in the sustainability and growth of their organisations, in support of its proposition as a partner to the NGO community. Finally, Courage has taken part in a range of academic endeavors to continue its leadership role in child protection globally.

This involved developing a poster and presenting the Courage toolkit and process to delegates. Courage was awarded first prize in the poster competition.</li> </ul>
<p><b>Child Centred Support Projects:</b> In support of their work with childhood disability, Courage took part in the following partnership programmes for children:</p> <ul style="list-style-type: none"> <li>• The Tara H Moross Psychiatry Hospital Children’s Ward Sensory Garden Development. Total cost of the project was R45 000-00 sponsored by D&amp;B Blackie.</li> <li>• The Fight with Insight - Boxing for Autism Programme Development.</li> </ul>	<p>The positive therapeutic impact of sensory rooms on children who experience challenges with sensory, emotional and social integration and regulation has been proven globally. With funding provided from private donors for this express purpose, Courage created a sensory garden catering to children diagnosed with autism, mood and anxiety disorders, trauma, attachment, self-harm, suicidal behaviour, aggression and relational difficulties. The Boxing for Autism Programme has also been proved to have a significant benefit for children diagnosed on the autism spectrum. Courage developed recommendations for the training booklet and assisted with brand development from a strategic perspective.</p>
